CITY SHARES WAYS TO PREVENT STORMWATER POLLUTION

Gardner has approximately 1,700 storm drains throughout the city with an intended purpose to carry rain water quickly off the streets. Anything dumped or dropped on the ground or in the gutter other than rain can end up in the nearest body of water and is known as stormwater pollution. This pollution occurs when pesticides and garden chemicals, soap from car washing, pet waste, oil from cars, and other random items get washed off lawns and streets, down storm drains, and into the water supply. Unlike a sanitary sewer, which transports wastewater to a treatment facility for cleaning before releasing it to a waterbody, water that enters a storm drain does not receive treatment/ cleaning before being discharged to the environment.

WHAT CAN RESIDENTS DO TO PREVENT STORMWATER POLLUTION?

There are many easy steps people can do each day to prevent stormwater pollution:

- Don't dump waste into storm drains.
- Keep yard clippings out of the street.
- Dispose of household chemicals properly by following the directions on the package or by calling Johnson County Household Hazardous Waste.
- Clean up oil spills and fix leaking automobiles.
- Use drip pans to catch engine oil and other pollutants while repairing cars.
- Recycle used motor oil.
- Sweep driveways clean instead of hosing them down.
- Water your lawn by hand or adjust sprinklers to avoid over-watering. If any water flows off your lawn, you're using too much water.



Ethan Smith of Troop 315 completed his Eagle conservation project of marking storm drains throughout the town with "No Dumping" medallions. With a group of volunteers and supplies from the city, Ethan tagged 240 drains to bring awareness that only rain belongs in the drains and to discourage dumping. - Wash your car at a commercial car wash, or at least wash your car on an unpaved surface so the ground can absorb the excess water.
- Drain swimming pools and spas into a sanitary sewer outlet, never into a street. Check first with your local wastewater treatment plant before disposing of anything in the sewer.

Johnson County monitors stormwater quality exiting Gardner's system. This monitoring would note if any pollutants were introduced into the city's stormwater system at levels significant enough to warrant source investigation.

NEW QUIKTRIP TRAVEL CENTER OPENS IN APRIL

Gardner will soon have a second QuikTrip in town located at the southwest corner of South Gardner Road and West 188th St. Unlike its Main Street predecessor, this store serves as a travel center, providing a wide range of products and services for a broader clientele. The approximately 8.8-acre project consists of the following:

- A 7,318 square-foot building
- Six semi-truck filling lanes containing 12 diesel pumps
- A truck parking area located along the southwest corner

The travel center is expected to serve the general drive-by public as well as the semi-truck traffic that services the intermodal facility.

US-56/MAIN STREET RECONSTRUCTION PROJECT

The US-56/Main Street Reconstruction Project is well underway! The project stretches nearly a mile long along US-56 from Sycamore Street to Old 56 Hwy. It consists of full-depth pavement reconstruction, removal and replacement of curb and gutter, driveway and sidewalk enhancements, a new traffic signal at the intersection between QuikTrip and Walgreens, signal timing interconnection between the new signal and the existing signal at Moonlight, reduction/combining of access points, and a new left-turn lane for eastbound traffic at Cedar Street. Currently, contractors are removing pavement from the two closed eastbound lanes. The two westbound lanes remain open for both directions of traffic. Currently, no left turns are allowed at Moonlight Road for motorists traveling eastbound on US-56/Main Street. Motorists should consider using an alternate route for areas experiencing heavy traffic and long waits. The project is scheduled to be completed by mid-November 2022.

PROJECT PHASING:

Phase 1: Sycamore to Moonlight, Eastbound Lanes

Phase 2: Sycamore to Moonlight, Westbound Lanes

Phase 3: Moonlight to Old 56, Center Lanes

Phase 4: Moonlight to Old 56, Outside Lanes



HEAR THE BEEP WHERE YOU SLEEP

Did you know half of home fire deaths happen between 11 p.m. and 7 a.m. when most are sleeping? That's why every bedroom needs a working smoke alarm. In fact, the Johnson County Fire District #1 recommends a fire alarm in every bedroom, outside of each separate sleeping area and on every level of the home, including the basement. For the best protection, residents should consider installing interconnected smoke alarms in their homes, which alerts all alarms to sound when one is activated.



Smoke Detector Instructions:

- Test alarms at least once a month by pushing the test button.
- Replace all 10-year-old smoke alarms or if they do not sound when tested.
- Some people, especially children and older adults, may need help to wake up. Make sure someone will wake them if the smoke alarm sounds.
- When the smoke alarm sounds, residents must get outside, stay outside and meet at their outside meeting place.
- Call the fire department from a cellphone or a neighbor's phone.
- Stay outside until the fire department says it's safe to go back inside.

JUSTICE CENTER SERVES AS TORNADO SHELTER FOR TORNADO WARNINGS

Spring is here, and with the warmer temperatures comes an increased chance for tornadoes. During this unpredictable weather season, the city wants to remind residents that the Gardner Justice Center serves as a Tornado Shelter for those without a safe place to go when tornadic weather strikes. The shelter is open for tornado warnings only. Hours of operation are from 8 a.m. to 5 p.m. If a tornado warning occurs outside of business hours, the Gardner Justice Center will become available when an officer reports back to the building. Pets are welcome to accompany their owners; however, individuals and their fur companions will



be separated from those without pets due to others who may be allergic or afraid of animals. For questions regarding the Justice Center serving as a tornado shelter, contact the Gardner Police Department at 913.856.7312.



POLICE DEPARTMENT STARTS A PET PANTRY

Earlier this year, the Gardner Police Department (GPD) started a pet pantry program to assist Gardner residents in need of food assistance for their pets. This service is offered once a month to qualified applicants. Qualifications for participation include current rabies vaccination, current City of Gardner pet license and completed GPD Pet Pantry application.
