## **RESOLUTION NO. 2111**

## A RESOLUTION LEVYING A PROPERTY TAX RATE EXCEEDING THE REVENUE NEUTRAL RATE FOR THE CITY OF GARDNER, KANSAS.

**WHEREAS**, the Revenue Neutral Rate for the City of Gardner, Kansas ("City") was calculated as 17.445 mills by the Johnson County Clerk; and

WHEREAS, the Fiscal Year 2023 Annual Budget and the City's intent to exceed the Revenue Neutral Rate have been discussed by the Governing Body at various City Council meetings and other public meetings noticed in accordance with state law; and

**WHEREAS**, the Fiscal Year 2023 Annual Budget proposed by the Governing Body of the City will require the levy of a property tax rate exceeding the Revenue Neutral Rate; and

**WHEREAS**, notice of publication of the City's intent to exceed the Revenue Neutral Rate and public hearing was made as provided by law; and

**WHEREAS**, the Governing Body of the City held a hearing on September 6, 2022 allowing all interested taxpayers desiring to be heard an opportunity to give oral testimony; and

**WHEREAS**, the Governing Body of the City, having heard testimony, finds it is in the best interest of the City to exceed the Revenue Neutral Rate.

## NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF GARDNER, KANSAS:

**SECTION ONE:** The City of Gardner, Kansas ("City"), a municipal corporation, does hereby authorize levying a property tax rate exceeding the Revenue Neutral Rate of 17.445 mills and levy the proposed tax rate of 18.854 mills for fiscal year 2023 as presented at the September 6, 2022 City Council meeting.

**SECTION TWO:** This Resolution shall take effect and be in force from and after its passage.

**SECTION THREE**: On or before October 1, 2022, the City's Finance Director, in coordination with the City Clerk, shall certify with the Johnson County, Kansas County Clerk (the "County Clerk") the amount of ad valorem tax to be levied and the total amount of the adopted Fiscal Year 2023 Annual Budget along with other information pertaining thereto in accordance with State law.
