

ORDINANCE NO. 2514

AN ORDINANCE DESIGNATING CERTAIN STREETS WITHIN THE CITY OF GARDNER, KANSAS, AS MAIN TRAFFICWAYS AND TRAFFICWAY CONNECTIONS, PURSUANT TO K.S.A. 12-685 *ET SEQ.*, AND REPEALING ORDINANCE NO. 2462.

WHEREAS, K.S.A. 12-685 authorizes the governing body of any city to designate and establish by ordinance as a main trafficway any existing or proposed street, boulevard, avenue or part thereof, within such city, the primary function of which is, or shall be, the movement of through traffic between areas of concentrated activity within the city or between such areas within the city and traffic facilities outside the city performing the function of a major trafficway; and

WHEREAS, K.S.A. 12-686 authorizes the governing body of any city to designate and establish by ordinance as a trafficway connection portions of existing streets, boulevards, avenues or viaducts as trafficway connections or to acquire by purchase or condemnation the necessary right-of-way for such purposes and designate and establish the same as trafficway connections and to connect any street, boulevard, avenue or viaduct with any of the main trafficways and/or connect two main trafficways; and

WHEREAS, pursuant to Ordinance No. 2462 of the city of Gardner, Kansas (the “City”), passed on November 3, 2014 (“Ordinance No. 2462”), the City has previously designated certain streets within the City as main trafficways or trafficway connections; and

WHEREAS, the Governing Body finds it necessary and desirable to repeal Ordinance No. 2462 and replace Ordinance No. 2462 with this Ordinance which designates those main trafficways or trafficway connections originally designated, along with additional main trafficways or trafficway connections, as part of a single ordinance;

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GARDNER, KANSAS, AS FOLLOWS:

Section 1. Pursuant to K.S.A. 12-685, the following streets are hereby designated as main trafficways, the primary function of which is the movement of through traffic between areas of concentrated activity within the City and between such areas within the City and traffic facilities outside the City:

- i. 159th Street within the city limits of the City;
- ii. 167th Street within the city limits of the City;
- iii. 175th Street (aka Santa Fe Street) within the city limits of the City;
- iv. 183rd Street (aka Cherokee Street) within the city limits of the City;
- v. 191st Street within the city limits of the City;

- vi. Center Street (aka Gardner Road) within the city limits of the City;
- vii. E. Grand Street from S. Center Street to S. Moonlight Road;
- viii. Kill Creed Road within the city limits of the City;
- ix. Madison Street within the city limits of the City;
- x. Main Street (Hwy 56) within the city limits of the City;
- xi. Moonlight Road within the city limits of the City;
- xii. N. Poplar Street from W. Madison Street to 167th Street;
- xiii. University Drive within the city limits of the City;
- xiv. Waverly Road within the city limits of the City;
- xv. White Drive within the city limits of the City;
- xvi. E. Wildcat Run Street from S. Moonlight Road to S. Woodson Lane; and
- xvii. S. Woodson Lane from S. Moonlight Road to E. Wildcat Run Street.

Section 2. Pursuant to K.S.A. 12-686, the following streets are hereby designated as trafficway connections which connect any street, boulevard, avenue or viaduct with any of the main trafficways and/or connect two main trafficways:

- i. W. 159th Terrace extending west from University Drive within the city limits of the City;
- ii. W. 160th Street extending west from University Drive within the city limits of the City;
- iii. W. 160th Terrace from University Drive to Canton Street;
- iv. W. 162nd Street extending east from University Drive within the city limits of the City;
- v. W. 162nd Terrace:
 - (a) From Canton Street to University Drive; and
 - (b) Extending east from University Drive within the city limits of the City;
- vi. W. 163rd Street extending west from University Drive within the city limits of the City;

- vii. W. 164th Street from University Drive to Blair Street;
- viii. W. 165th Street extending east from Kill Creek Road within the city limits of the City;
- ix. W. 165th Terrace extending east from Kill Creek Road within the city limits of the City;
- x. W. 166th Street:
 - (a) From Lyons Street to Kill Creek Road; and
 - (b) Extending east from Kill Creek Road within the city limits of the City;
- xi. E. 167th Terrace from N. Cedar Street to N. Moonlight Road;
- xii. W. 170th Street from Agnes Street to N. Waverly Road;
- xiii. W. 171st Street from Oakley Street to W. 172nd Street;
- xiv. W. 172nd Street extending east and west from Osage Street within the city limits of the City;
- xv. W. 172nd Terrace from S. Walter Street to N. Waverly Road;
- xvi. W. 174th Street:
 - (a) Extending east from Kill Creek Road within the city limits of the City; and
 - (b) From Agnes Street to S. Waverly Road;
- xvii. W. 174th Terrace extending east from Kill Creek Road within the city limits of the City;
- xviii. W. 184th Street extending west from S. Center Street within the city limits of the City;
- xix. W. 185th Street extending east from S. Center Street within the city limits of the City;
- xx. W. 186th Street extending east from S. Center Street within the city limits of the City;
- xxi. W. 188th Street extending east and west from Gardner Road within the city limits of the City;

 - (b) W. Skylark Street to N. Poplar Street;
- xxx. N. Buckeye Street extending south from W. Madison Street within the city limits of the City;
- xxxi. Butternut Street extending south from W. Cherokee Street within the city limits of the City;
- xxxii. Canton Street from 183rd street extending south within the city limits of the City;
- xxxiii. Cedar Niles Road extending north and south from E. Santa Fe Street within the city limits of the City;
- xxxiv. Cedar Street:
 - (a) Extending north from E. Main Street (Hwy 56) within the city limits of the City; and
 - (b) From E. Grand Street to W. 183rd Street;
- xxxv. N. Cherry Street from E. Washington Street to N. Mulberry Street;
- xxxvi. E. Cheyenne Street from S. Maple Street to S. White Drive;
- xxxvii. Circle Drive extending north from W. Main Street (Hwy 56) within the city limits of the City;
- xxxviii. City Lane from N. Center Street to N. Elm Street;

- xxxix. Colleen Court:
 - (a) From N. Poplar Street to N. Center Street; and
 - (b) Extending east from N. Center Street within the city limits of the City;
- xl. Colleen Drive from:
 - (a) N. Mulberry Street to N. Oak Street; and
 - (b) N. White Drive to the eastern intersection of E. Colleen Drive and E. Valerie Lane;
- xli. W. Colleen Street extending west from N. Poplar Street within the city limits of the City;
- xl.ii. Conestoga Street from E. Santa Fe Street to E. Warren Street;
- xl.iii. Cottage Creek Circle extending west from Woodson Lane within the city limits of the City;
- xl.iv. E. Cottage Creek Drive from:
 - (a) S. Moonlight Road to S. Stone Creek Drive; and
 - (b) S. Stone Creek Drive to S. Woodson Lane;
- xl.v. N. Cottonwood Street:
 - (a) From W. 167th Street to E. 167th Terrace; and
 - (b) Extending south from E. Madison Street within the city limits of the City;

 - (b) Extending east from N. White Drive within the city limits of the City;
- xc. W. Skylark Circle extending east from N. Poplar Street within the city limits of the City;
- xc. Skylark Street from:
 - (a) N. Maple Street to N. Cedar Street; and
 - (b) N. Center Street to N. Poplar Street;
- xcii. Spruce Street:
 - (a) From W. 167th Street to N. Mulberry Street;

- (b) Extending north from E. Madison Street within the city limits of the City; and
 - (c) From W. 183rd Street to W. 186th Street;
- xciii. S. Stone Creek Drive:
 - (a) From S. Woodson Lane to E. Wildcat Run Street; and
 - (b) Extending south from S. Woodson Lane within the city limits of the City;
- xciv. Sumac Street:
 - (a) Extending south from E. Madison Street within the city limits of the City; and
 - (b) From W. 183rd Street to E. Cheyenne Street;
- xcv. Sycamore Street from:
 - (a) E. Washington Street to E. Warren Street; and
 - (b) E. Pawnee Lane to W. 183rd Street;
- xcvi. E. Valerie Lane from the eastern intersection of E. Valerie Lane and E. Colleen Drive to E. Parma Way;
- xcvii. Walnut Street from:
 - (a) W. 167th Street to W. Skylark Street; and
 - (b) W. McKinley Street to W. Main Street (Hwy 56);
- xcviii. Walter Street extending north from W. Santa Fe Street within the city limits of the City;
- xcix. Warren Street:
 - (a) Extending east and west from S. Moonlight Road within the city limits of the City; and
 - (b) From S. Sycamore Street to W. Main Street (Hwy 56);
- c. E. Washington Street:
 - (a) Extending east and west from N. White Drive within the city limits of the City; and
 - (b) Extending east from N. Center Street within the city limits of the City;

- ci. E. Westhoff Court extending east from N. Center Street within the city limits of the City;
- cii. Westhoff Place from:
 - (a) N. Center Street to N. Mulberry Street; and
 - (b) N. Poplar Street to W. Colleen Court;
- ciii. White Circle extending west from N. White Drive within the city limits of the City;
- civ. Wildcat Court extending south from Wildcat Run Street within the city limits of the City;
- cv. N. Winwood Street from N. White Drive to E. Parma Way;
- cvi. Winwood Terrace from N. White Drive to E. Parma Way; and
- cvii. Woodson Circle extending west from Woodson Lane within the city limits of the City.

Section 3. Ordinance No. 2462 is hereby repealed and replaced by this Ordinance.

Section 4. This Ordinance shall take effect and be in force from and after its passage and publication as required by law.
