Title 14 - Flood Plain Management

Additional fees of \$500 per submittal will be assessed for inaccurate modeling or incomplete submittals resulting in more than three submittals of the HEC-RAS model and supporting documentation.

Title 15 – Buildings and Construction

1. See Table A –Square Foot Construction Cost Table (per 15.05.020 and 15.50.020) Building Valuation Data (BVD labeled Table A - square foot construction costs table) Adjustment for the City of Gardner, Kansas. Table A sets the building valuation based on the occupancy and type of construction and is to include the total value of all construction work. The value to be used in computing the building permit and building plan review fees shall be the total value of all construction work, for which the permit is issued as well as all finish work, roofing, electrical, plumbing, heating, air conditioning, elevators, fire extinguishing systems and any other permanent equipment. For the factory built structures, the determination of value shall be based the same as for a built on site structure. The Codes Administrator shall determine the occupancy and construction type for Table A which is supplied by the ICC. The values are based on 100% of the 2009 ICC table.

All Plan Review Fees are calculated at 60% of the building permit fee in Table A. All permit fees are regulated by the Business and Economic Development Department. Outside third party plan reviews will be paid by the owner or applicant.
