

RESOLUTION NO. 1969

A RESOLUTION AUTHORIZING THE CITY OF GARDNER, KANSAS, TO CONSTRUCT IMPROVEMENTS TO CERTAIN MAIN TRAFFICWAYS AND TRAFFICWAY CONNECTIONS AND AUTHORIZING THE ISSUANCE OF GENERAL OBLIGATION BONDS OF THE CITY TO PAY THE COSTS THEREOF PURSUANT TO K.S.A. 12-685 *ET SEQ.*

WHEREAS, K.S.A. 12-685 *et seq.* (the “Act”) authorizes the Governing Body of the city of Gardner, Kansas (the “City”), to construct improvements to streets designated as main trafficways or trafficway connections under the Act and to issue general obligation bonds of the City for such purpose;

WHEREAS, pursuant to Ordinance No. 2514 of the City passed on May 2, 2016 (the “Trafficway Ordinance”), the City has designated certain streets or portions of streets within the City as main trafficways including the following:

- (a) 175th Street (aka Santa Fe Street) within the city limits of the City;
- (b) Kill Creek Road within the city limits of the City; and
- (c) White Drive within the city limits of the City;

WHEREAS, pursuant to the Trafficway Ordinance, the City has also designated certain streets or portions of streets within the City as trafficway connections including the following:

- (a) E. 167th Terrace from N. Cedar Street to N. Moonlight Road;
- (b) W. 170th Street from Agnes Street to N. Waverly Road;
- (c) W. 171st Street from Oakley Street to W. 172nd Street;
- (d) W. 172nd Street extending east and west from Osage Street within the city limits of the City;
- (e) W. 174th Street extending east from Kill Creek Road within the city limits of the City;
- (f) W. 174th Terrace extending east from Kill Creek Road within the city limits of the City;
- (g) N. Birch Street from N. Sumac Street to E. Madison Street;
- (h) Bluebird Street from:
 - 1. N. Maple Street to N. Cedar Street; and
 - 2. W. Skylark Street to N. Poplar Street;

- (i) Cedar Street extending north from E. Main Street (Hwy 56) within the city limits of the City;
- (j) N. Cherry Street from E. Washington Street to N. Mulberry Street;
- (k) Colleen Court:
 - 1. From N. Poplar Street to N. Center Street; and
 - 2. Extending east from N. Center Street within the city limits of the City;
- (l) Colleen Drive from:
 - 1. N. Mulberry Street to N. Oak Street; and
 - 2. N. White Drive to the eastern intersection of E. Colleen Drive and E. Valerie Lane;
- (m) Conestoga Street from E. Santa Fe Street to E. Warren Street;
- (n) N. Cottonwood Street from W. 167th Street to E. 167th Terrace;
- (o) Evergreen Street from N. Birch Street to E. Lincoln Lane;
- (p) W. Fountain Street extending east from N. Waverly Road within the city limits of the City;
- (q) W. Grand Street from S. Center Street to S. Pine Street;
- (r) Jessica Street from W. 175th Street to W. 171st Street;
- (s) E. Lincoln Lane from N. White Drive to Aspen Lane;
- (t) W. Meadowlark Street from N. Poplar Street to N. Walnut Street;
- (u) Mockingbird Street:
 - 1. Extending east from N. Waverly Road within the city limits of the City; and
 - 2. Extending east and west from N. White Drive within the city limits of the City;
- (v) Mulberry Street from E. Washington Street to E. Park Street;
- (w) Oak Street from W. Grand Street to W. 184th Street;
- (x) Osage Street extending north from W. 175th Street within the city limits of the City;
- (y) E. Parma Way from N. Moonlight Road to N. White Drive;
- (z) Shawnee Street:
 - 1. From N. Walnut Street to N. White Drive; and
 - 2. Extending east from N. White Drive within the city limits of the City;

- (aa) Skylark Street from:
 - 1. N. Maple Street to N. Cedar Street; and
 - 2. N. Center Street to N. Poplar Street;
- (bb) Sycamore Street from E. Washington Street to E. Warren Street;
- (cc) Walnut Street from W. 167th Street to W. Skylark Street;
- (dd) Walter Street extending north from W. Santa Fe Street within the city limits of the City;
- (ee) Warren Street:
 - 1. Extending east and west from S. Moonlight Road within the city limits of the City; and
 - 2. From S. Sycamore Street to W. Main Street (Hwy 56);
- (ff) E. Washington Street:
 - 1. Extending east and west from N. White Drive within the city limits of the City; and
 - 2. Extending east from N. Center Street within the city limits of the City;
- (gg) E. Westhoff Court extending east from N. Center Street within the city limits of the City;
- (hh) Westhoff Place from N. Poplar Street to W. Colleen Court;
- (ii) N. Winwood Street from N. White Drive to E. Parma Way; and
- (jj) Winwood Terrace from N. White Drive to E. Parma Way;

WHEREAS, the Governing Body of the City has determined that it is necessary to construct certain improvements within the city limits to streets or portions of streets designated as main trafficways or trafficway connections pursuant to the Act consisting of:

- (a) surface preservation, including materials, equipment and labor for asphalt surface treatments, curb and gutter replacement, storm sewer replacement, localized base repair, crack sealing, edge milling, up to 2” asphalt overlay, sidewalk ramp replacement and all related appurtenances for the following streets (collectively, the “Surface Preservation Improvements”):
 - 1. E. 167th Terrace from N. Moonlight Road to N. Cedar Street;
 - 2. W. 171st Street from Oakley Street to W. 172nd Street;
 - 3. W. 170th Street from Agnes Street to Waverly Road;

4. W. 172nd Street from terminus north of W. 171st Street extending to western City Limits;
5. W. 174th Street from Kill Creek Road to the cul-de-sac east of Kill Creek Road;
6. W. 174th Terrace from Kill Creek Road to the cul-de-sac east of Kill Creek Road;
7. Bluebird Street:
 - (i) from Poplar Street to N. Walnut Street; and
 - (ii) from N. Maple Street to N. Cedar Street;
8. N. Cedar Street from terminus north of Lincoln Lane to Main Street (Hwy 56);
9. N. Cherry Street from E. Madison Street to E. Washington Street;
10. W. Colleen Court from Poplar Street to Center Street;
11. W. Colleen Drive from N. Oak Street to Center Street;
12. W. Fountain Street from N. Waverly Road to terminus east of N. Laurel Street;
13. Jessica Street from W. 171st Street to W. 175th Street;
14. Kill Creek Road from terminus north of W. 171st Street to W. 175th Street;
15. E. Lincoln Lane from N. White Drive to N. Cedar Street;
16. W. Meadowlark Street from Poplar Drive to Walnut Street;
17. Mockingbird Street:
 - (i) from Waverly Road to N. Laurel Street; and
 - (ii) from White Drive to N. Cedar Street;
18. Osage Street from terminus north of W. 171st Street to W. 175th Street;
19. Skylark Street:
 - (i) from N. Poplar Street to N. Bluebird Street;
 - (ii) from the eastern intersection with W. Mockingbird Street to Center Street; and
 - (iii) from N. Maple Street to N. Cedar Street;
20. N. Walnut Street from W. Skylark Street to W. Bluebird Street;

21. Walter Street from W. Madison Street extending north to end of cul-du-sac;
22. E. Washington Street from N. Sycamore Street to White Drive;
23. W. Westhoff Place from N. Poplar Street to W. Colleen Court;
24. N. White Drive from Main Street (Hwy 56) to terminus north of Lincoln Lane; and
25. N. Winwood Terrace from N. White Drive to E. Parma Way; and

(b) major maintenance, including materials, equipment and labor for asphalt major maintenance, curb and gutter replacement, storm sewer replacement, localized base repair, full width mill, 2" or greater asphalt overlay, sidewalk ramp replacement and all related appurtenances for the following streets (collectively, the "Major Maintenance Improvements"):

1. N. Birch Street from E. Madison Street to N. Sumac Street;
2. W. Bluebird Street from N. Walnut Street to W. Skylark Street;
3. E. Colleen Court from Center Street to cul-de-sac east of Center Street;
4. E. Colleen Drive from N. White Drive to eastern intersection with E. Valerie Lane;
5. Conestoga Street from E. Santa Fe Street to E. Warren Street;
6. N. Cottonwood Street from E. 167th Street to E. 167th Terrace;
7. N. Evergreen Street from E. Madison Street to N. Birch Street;
8. W. Grand Street from S. Pine Street to S. Center Street;
9. N. Mulberry Street from Main Street (Hwy 56) to E. Shawnee Street;
10. S. Oak Street from W. Grand Street to W. 183rd Street (aka Cherokee Street);
11. E. Parma Way from N. Moonlight Road to N. White Drive;
12. E. Santa Fe Street from N. Moonlight Road to Zachary Drive;
13. E. Shawnee Street from Center Street to terminus east of N. Cedar Street;
14. W. Skylark Street from N. Bluebird Street to eastern intersection with W. Mockingbird Street;
15. N. Sycamore Street from Main Street (Hwy 56) to E. Washington Street;

16. N. Walnut Street from E. 167th Street to W. Bluebird Street;
17. Warren Street:
 - (i) from Main Street (Hwy 56) to Pine Street; and
 - (ii) from S. Moonlight Road to Conestoga Street;
18. E. Washington Street from Center Street to N. Elm Street;
19. Westhoff Court from Center Street to cul-de-sac east of Center Street; and
20. Winwood Street from N. White Drive to Parma Way; and

WHEREAS, the aggregate estimated cost of the Surface Preservation Improvements and the Major Maintenance Improvements (collectively, the “Trafficway Improvements”) to be financed under the Act is \$1,450,000, and it is necessary and desirable to pay such costs through the issuance of general obligation bonds of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GARDNER, KANSAS:

Section 1. In accordance with the Act, the Governing Body of the City hereby finds and declares the necessity for and authorizes the Trafficway Improvements.

Section 2. For the purpose of providing funds to pay the cost of the Trafficway Improvements, the City authorizes the issuance of its general obligation bonds in an aggregate amount not to exceed \$1,450,000 pursuant to the Act.


Section 3. The obligations authorized by this Resolution are authorized to reimburse expenditures made by the City 60 days before and during the time after the date of this Resolution in accordance with United States Treasury Regulation 1.150-2.

Section 4. This Resolution shall be in full force and effect from and after its adoption by the Governing Body of the City.
