A RESOLUTION INDICATING THE GOVERNING BODY APPROVAL OF THE INTENTION OF BELMONT DEVELOPMENT COMPANY LLC TO MAKE AN APPLICATION TO THE KANSAS HOUSING RESOURCES CORPORATION TO SECURE HOUSING TAX CREDITS MADE AVAILABLE THROUGH THE HOUSING TAX CREDIT PROGRAM THAT COULD ENABLE, IF AWARDED, THE CONSTRUCTION OF AFFORDABLE RENTAL HOUSING FOR BELMONT DEVELOPMENT COMPANY LLC LOCATED ON 9.40 ACRES NORTH WEST OF THE INTERSECTION OF UNIVERSITY DRIVE AND MOONLIGHT ROAD IN GARDNER KANSAS.

SECTION ONE: We support and approve Belmont Development Company LLC application to the Kansas Housing Resources Corporation to secure housing tax credits made available through the Housing Tax Credit Program that could enable, if awarded, the construction of affordable rental housing subject to city ordinances and the planning and building permit processes.
